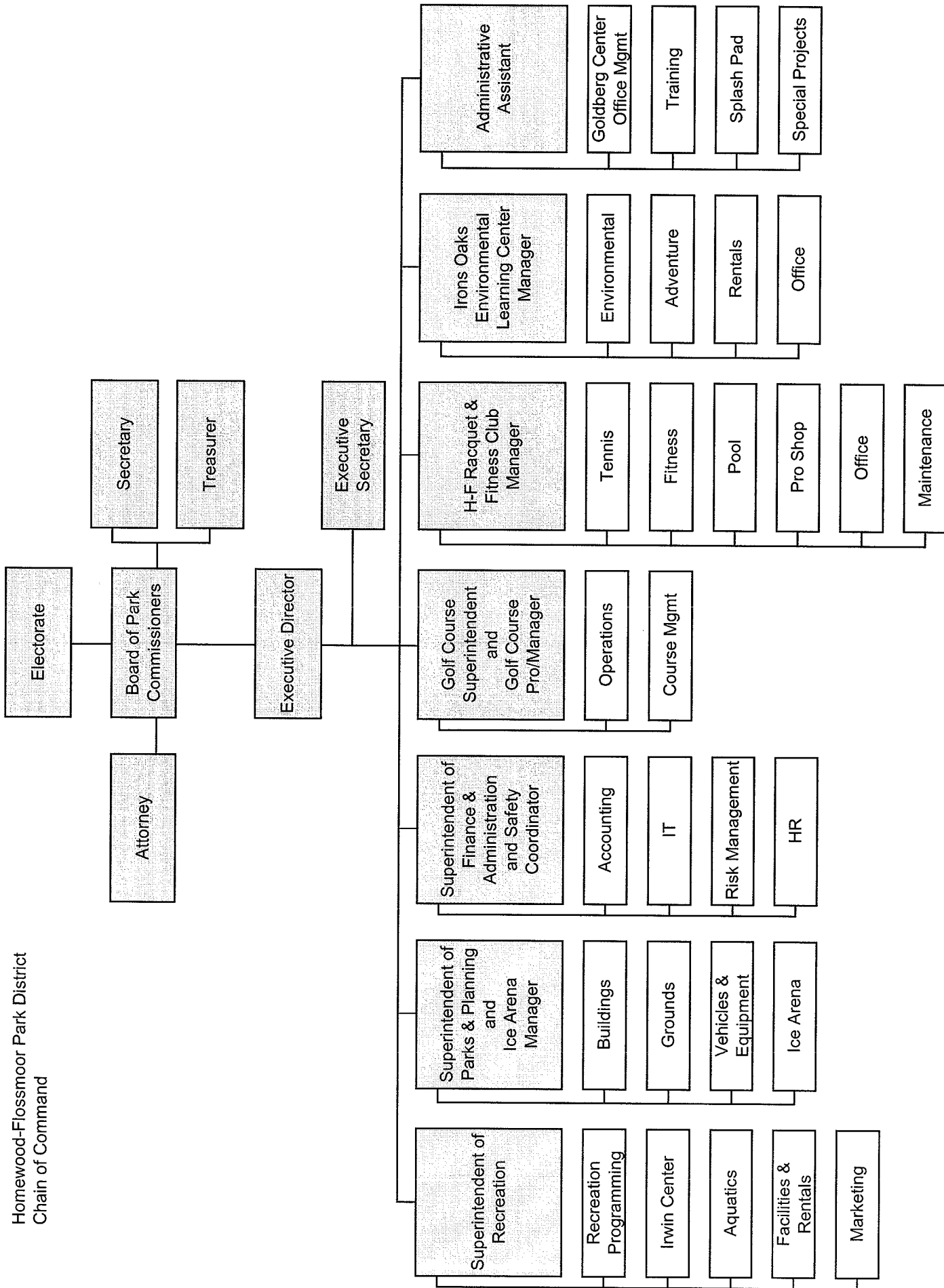

PUBLIC INFORMATION AND REQUEST POLICY

The Homewood-Flossmoor Park District is a unit of local government founded in 1969, organized and incorporated under the laws of the State of Illinois which has the purpose of providing leisure services and facilities for the residents of Homewood and Flossmoor. The Board of Park Commissioners of the Homewood-Flossmoor Park District is considered the local legislative body to which is entrusted, by the law, the responsibility for planning, executing and appraising park and recreation programs and facilities of the District. It is the duty of the Board to approve basic policy for the operation, control and planning of future and present activities of the District.

The Park District is governed by the following non-paid Board of Commissioners: Steve Johnson, President; Susan Bertram, Vice President; Dallas Collins, Commissioner; Robert Haderlein, Commissioner; and Patrick Nevins, Commissioner.

The Homewood-Flossmoor Park District has certain functional subdivisions, which are shown on the organization chart on page 3. The operating budget for 2010-2011 is \$13,604,077. The Homewood-Flossmoor Park District employs 50 full-time staff and over 700 part-time and seasonal workers. Major facilities of the Homewood-Flossmoor Park District include:

- Irons Oaks Environmental Learning Center, 20000 Western Avenue, Olympia Fields

If records must be certified, this must be indicated in the request. The fees for any such records, if the person requesting the records wished them to be copied, are as follows:

- No charge for the first fifty (50) black and white pages.
- Over fifty (50) black and white copies: 1 cent per page.
- Color copies: 6 cents per page.
- Electronic copies: cost of the medium.
- \$1.00 to certify copies.
